**TENDER NOTICE**

Centre for Chronic Disease Control (CCDC) invites sealed tender offers from eligible manufacturers/authorized distributors/resellers for the supply of **ELISA kits for the assay of human 1) Renin, 2) Angiotensin II, 3) Norepinephrine, , 4) Procollagen type III N-terminal propeptide (PIIINP/ P3NP), 5) Matrix Metalloproteinase-2 (MMP-2), & 6) collagen type I carboxy-terminal telopeptide (ICTP)** in the office of the Undersigned at the Second Floor, C-1/52, Safdarjung Development Area, New Delhi 110016.

The vendors intending to bid may submit their bid/tender by **Monday, 1<sup>st</sup> December 2025** to the following address:

The bid will be accepted till 5 p.m. on **Monday, 1st December 2025**. **Bid will not be accepted after the deadline i.e. after 5:00 p.m. on Monday, 1st December 2025.**

**TENDER SPECIFICATIONS:**

Sealed tenders are invited containing two types of bid i.e. Technical bid and Financial bid.

The technical bid should consist of all technical details including the manufacturer and the country of origin along with delivery schedule It should be in a sealed envelope with a clear marking as “TECHNICAL BID”.

The financial bid must contain item-wise prices separately for all items mentioned in the technical quotation, terms and conditions, mode of payment, and delivery schedule. The financial bid may also include custom duty and clearance charges if applicable. It should be in a sealed envelope with clear marking on the left-hand side as “FINANCIAL BID”.

Both of these sealed “TECHNICAL BID” and “FINANCIAL BID” must be put in a bigger envelope, which should also be sealed and super scribed. Separate envelopes must be used for each item mentioning its name. Non-compliance with the above may result in rejection of the tender. The word “**Tender for ELISA kits**” should be written prominently on the top of the envelope. Kindly mention the **delivery time** after the reception of purchase order. Payments will be made according to the rules of the institute.

Vendors should submit all the required documents on their letterhead. No separate Performa will be provided to them.

**TERMS AND CONDITIONS FOR TENDER:**

A) The vendor should have reputed background and should be established in business for at least five years.

B) The vendor should submit:

- a) Company profile for at least five years.
- b) Certificate that company is not blacklisted by any government organization.
- c) Three years income tax return.
- d) User list with name & address.

**Name of ITEMS:** The kits are required for analysis of human samples 1. Renin, 2. Angiotensin II, 3. Norepinephrine, 4. Procollagen type III N-terminal propeptide (PIIINP/ P3NP), 5. Matrix Metalloproteinase-2 (MMP-2), & 6. Collagen type I carboxy-terminal telopeptide (ICTP). Preference will be given to tender quoting kits from standard companies like Quantikine (R&D), Novus Biologicals, Invitrogen (Thermo), Immuno Diagnostics System (Australia), DRG (Germany), Labor Diagnostica Nord (GmbH, Germany). Also, kits with in-built controls will be preferred. In cases where in-built controls are not available, vendors should be able to supply third party control.

**Number of kits required:** 14 for each parameter.
